Conc Our best wishes for the New Year 2025

Your Excellency, Minister of Mines,

We encourage you to restore the rule of law necessary for the development of the Republic in order to reassure serious investors to come and settle permanently.

Allow me, Excellency, to wish you our best wishes for happiness, health and success for this New Year 2025.

This letter of wishes closes a Year 2024 which saw our 3PR 1323, 1324 & 1325 finally recognized as valid for never having been canceled and in force majeure for failure to issue research certificates. In addition, the non-existence of the 36PR granted to Dan Gertler who spoliated our 3PR cannot be contested (see https://thaurfin.com/INEXISTENCE.pdf), all the unfair judicial decisions that considered them are wiped out by virtue of the maxim *the accessory (these judicial decisions) follows the principal (the patent non-existence of these 36PR)*.

These evidences had been transmitted by this synthesis cf https://thaurfin.com/SYNTHESE.pdf . You will find on https://thaurfin.com/courriers/ the numerous letters which transmit them.

On October 9, 2024, we transmitted this letter https://thaurfin.com/TH-040-24.pdf according to which our lawyer Me Mbala, in copy, spoke with the Legal Director of CAMI who could only recognize the facts and documents presented. The Ministry of Mines acknowledged receipt as well as CAMI and Me Mbala who reported to me the results of his meeting with the DJ of CAMI.

After 18 days of receiving this letter and having received no response, we transmitted this letter https://thaurfin.com/TH-041-24.pdf of October 29 to the same recipients who acknowledged receipt. "If silence alone does not constitute acceptance, it is not the same when circumstances allow this silence to be given the meaning of acceptance." Circumstantial silence constitutes acceptance.

These circumstances are the many letters sent that do not allow the recipients of additional responsibilities to ignore them while they have acknowledged receipt.

These 3PR 1323, 1324 & 1325 having been recognized as valid and in force majeure since their granting, we have requested that they appear on the mining cadastre portal. This request appears in the many letters sent https://thaurfin.com/courriers/



This December 24, 2024, it seemed necessary to provide clarifications to this letter TH-046-24, insofar as the new violation of having recently granted a PR15633 to Chinese people from the Oracle Mining company on our 2PR 1323 & 1325 can be interpreted as a provocation.

In response to the message of wishes from the Chairman of the Board of Directors of CAMI to His Excellency Mr. Félix Tshisekedi, to the deputies and senators as well as to the members of the Government, we responded with the letter of wishes TH-049-24 on December 26, 2024 by email of the same day.

This message of wishes for the New Year 2025 (in annex) transmitted the directives of the Head of State regarding the restoration of a rule of law necessary to guarantee the security of investors.

On December 12, 2024, the Ministry of Mines invited the Director General of the Mining Cadastre to come and present an inventory of this file (see https://www.thaurfin.com/Scan.pdf); to date, we have not received any response. The last offense of having signed the Ministerial Orders relating to the non-existent PR15633 since in flagrant violation of article 34 of the mining code then represents an insult to the Head of State.

As we have expressed, a request for arbitration at the ICSID was abandoned because it contradicted our aspirations. We therefore ask you to work to avoid the opprobrium to the Republic that such a request will imply exposing the range of offenses in this case (see https://thaurfin.com/DELITS.pdf); it is preferable to leave them in the past which must be over.

We hope that together, we will highlight these 3PR 1323, 1324 and 1325 by participating in the development of the Republic while benefiting from the emergence of a new equitable world.

Wishing you our best wishes for this New Year 2025, we ask you to accept, Excellency Mr. KIZITO KABINGA MULUME, the expression of our best feelings,
